

Explanation	 Abbott Diagnostics has received the attached letter from Inpeco, the supplier of the ACCELERATOR a3600 Centrifuge Module. Inpeco recommends an immediate reduction in the operating speed of the centrifuge not to exceed a maximum of 3500 RPMs. Material changes may have an impact on the strength of the buckets, which could lead to the bucket becoming dislodged in the centrifuge. There have been no reports from ACCELERATOR a3600 customers of any centrifuge module failures. However, if a centrifuge fails, there is the potential for: Operator biohazard exposure (due to broken sample tubes) Operator physical hazard (due to broken glass within the centrifuge or the centrifuge moving unexpectedly). 				
Patient Impact	If a centrifuge failure occurs, processing of patient samples may be delayed.				
Necessary Actions	 Implement the following immediately: 1. Do not exceed a maximum of 3500 RPMs. This corresponds to an RCF (g) value of 2657. This value meets the requirements for the centrifugation of commonly used blood sample tubes:

	<i>NOTE</i> : Reduction of RPMs may impact overall track workflow and turn around times due to the potential of increased centrifugation time.				
	 Per the Hettich Centrifuge operating instructions (AB5680DEENFRIT), when the centrifuge is running, according to EN/IEC 61010-2-020, no persons, dangerous substances or objects may be within the safety margin of 1 foot (300 mm) around the centrifuge. 				
	3. Visually inspect your centrifuge buckets for cracks, particularly at the inner edge of the suspension groove. Cracks can be identified more easily using a magnifying glass. If any cracks are identified OR if the "useable until" date has expired.
