  - If a reagent kit of lot 18439M503 is impacted, Error Code 1072 will occur and prevent completion of calibration and/or reporting results.
  - A reagent kit of lot 18439M503 that is not impacted will run successfully with no error code.
- There is no impact to other AxSYM Valproic Acid Reagent lots.
