### **Urgent Medical Device Correction – 2955842-11-26-2014-011-C**

Wheels on da Vinci<sup>®</sup> Si<sup>®</sup> Systems (IS3000) Vision Side Carts

Introduction	Dear da Vinci Customer,						
and Reason for Field Action	This Medical Device Correction is to advise you that Intuitive Surgical is initiating voluntary correction related to <i>da Vinci Si</i> System (IS3000) Vision Side Carts, which threaded-in caster wheels. This wheel design was manufactured until 2010.						
	Intuitive Surgical has found that repeated attempts to move a Vision Side Cart with threaded-in caster wheels, and in which one or more of the wheels is in the locked position, can result in the caster wheel bolts gradually unthreading and the wheels loosening. In this scenario, the bolts could loosen until the wheels dislodge from the cart.  Starting in 2010, the caster wheel design was changed to a new design. Only systems with the threaded-in caster wheels are affected by this issue. There were 202 Vision System Carts manufactured with the threaded-in design.  Previous models of the <i>da Vinci</i> System (IS1200, IS2000) and the newer <i>da Vinci Xi</i> (IS4000) Vision Side Carts do not use this threaded-in caster wheel design in their wheel assembly and are therefore not affected by this issue.						
Risk to Health	In the identified situation, there is a risk of injury to OR staff if a wheel becomes loose, the Vision Side Cart becomes unstable and/or equipment falls from its shelves. The Vision Side Cart does not come in contact with the patient.

Avoid rolling the Vision Side Cart over uneven surfaces (i.e., over cables or a threshold).</li> <li>4. Complete and return the attached Acknowledgement Form to Intuitive Surgical using the instructions provided.</li> <li>5. Please retain a copy of this notice with your da Vinci Si user manual.</li> </ul>
Actions to be taken by Intuitive Surgical	<ol> <li>Intuitive Surgical representatives will be available by phone to answer questions related to this Medical Device Correction.</li> <li>The Preventive Maintenance (PM) frequency for the VSC caster wheel assemblies will be increased from every six months, during system PM, to every three months. During these visits, the Intuitive Surgical Field Service representative will inspect the integrity of the caster wheel assembly and tighten any wheels found to be loose.</li> <li>Intuitive Surgical is working on a newly designed wheel assembly. Upon availability, Field Service will retrofit the wheel assembly of the affected Vision Side Carts with the new design. Once the retrofit is completed, the preventive maintenance frequency for the VSC caster wheel assemblies will return to every six months.</li> </ol>
