# URGENT MEDICAL DEVICE RECALL - FIELD NOTIFICATION ATRIUM OCEAN, OASIS, EXPRESS and EXPRESS MINI CHEST DRAINS Packaging Configuration Clarification All Lot Numbers With Expiration Date Prior To October 2019

Manufacturing Dates: October 2011 to October 2016

## PLEASE FORWARD THIS INFORMATION TO ALL USERS AND STAFF WHO MAY USE ATRIUM CHEST DRAIN PRODUCTS.

#### Dear Risk Management Staff,

This letter is intended to provide clarification about the current packaging configuration of the Atrium Ocean, Oasis, Express and Express Mini chest drainage products. Atrium chest drainage products are packaged with a double sequential sterile wrap and placed into an outer dust cover. The dust cover is folded over and secured with the package label.

This packaging system is the same configuration used on Atrium chest drainage products for the past 30 years. This Field Notification is to provide clarification as to which part of the packaged drain is sterile.

The label on the outer package denotes the product as being sterile. The chest drain inside the packaging is sterile; the outer dust cover is not sterile. The two sterilization wraps are what provide the sterile barrier for the product.

Please inform responsible personnel of the following steps for introduction of the Atrium Chest Drains into the sterile field.

#### To introduce the chest drain into the sterile field:

- 1. Remove the wrapped chest drain from the dust cover.
- 2. Open the 2 sterilization wraps using sterile technique.
- 3. Only enter the chest drain into the sterile field.

This Field Notification applies to all Atrium chest drain products listed in Table 1 (ref. **Attachment 1**) with an expiration date prior to October 2019.

#### **NEW WARNING LABEL:**

Atrium Chest Drains manufactured after October 18, 2016 will contain a new warning label that identifies the pouch as not being a sterile barrier and warns the user that only the chest drain can be entered into the sterile field.

Atrium Chest Drains having lot number 244887 and higher will contain the new warning label.

A copy of the new warning label is provided as **Attachment 2**.

#### **ACTIONS FOR USERS:**

- Please ensure that all Atrium chest drain users are aware of the new warning label.
- Please make copies of new warning label (ref. **Attachment 2**) and post the warning label near all Atrium chest drain product inventory with expiration date prior to October 2019.
