This letter is to advise you of a voluntary Field Safety Corrective Action initiated by Alcon for specific lots of Alcon's 23G TotalPLUS Paks and 23G Combined Procedure Packs. These products contain an infusion cannula that may not securely fit into the 23G non-valved trocar cannula.

National Competent Authorities have been notified of this action.

Details on Affected Devices:

The Alcon 23G non-valved trocar cannula and infusion cannula are both single use consumable items used to provide internal access to the ocular cavity and the infusion of fluid or air during surgery. The 23G non-valved trocar cannula and infusion cannula are available as components within Accurus® and Constellation® TotalPLUS® Paks and Combined Procedure Packs. The impacted Alcon part numbers are summarized in the following table.

Description of the Problem:

Alcon confirmed complaints for the 23G non-valved trocar cannula and infusion cannula related to a loose fit between the non-valved trocar cannula and infusion cannula. This loose fit may cause the infusion cannula to dislodge from the trocar cannula during the surgical procedure, which may eliminate the necessary infusion to the eye required to maintain adequate pressure while operating.

Action to be Taken by the Customer for TotalPLUS® Paks and Combined Packs:

Since the safety of the patients is at the center of what we do at Alcon, we will strongly advise our customers **NOT** to use the non-valved trocar cannula for infusion. To minimize disruption and ensure continuous patient care, replacement valved trocar cannulas will be provided to your facility at no charge.

Please follow these important steps for utilizing your replacement valved trocar cannula:
